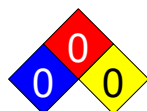

7 Handling and Storage

Pressurized container: protect from sunlight and do not expose to temperatures exceeding 50°C, i.e. electric lights. Do not pierce or burn, even after use.

Full and empty cylinders should be segregated. Use a "first-on, first-out" inventory system to prevent full containers from being stored for long periods of time.
